THIS SWEEPSTAKES IS INTENDED FOR PARTICIPATION IN THE FIFTY (50) UNITED STATES AND DISTRICT OF COLUMBIA ONLY AND WILL BE GOVERNED BY U.S. LAW. DO NOT ENTER IF YOU ARE NOT LOCATED IN THE UNITED STATES. Further eligibility restrictions are contained in the Official Rules below. Non-compliance with these Official Rules shall result in disqualification from the Sweepstakes.

1. DESCRIPTION: The America's Biggest Cheapskate **Sweepstakes** (the "**Sweepstakes**") begins Sunday, June 23, 2024 at 12:01 am Eastern Time ("**ET**"), and ends at 11:59pm ET on Sunday, July 28, 2024 (the "**Sweepstakes Period**"). The Sweepstakes Period consists of four (4) individual week long entry periods (each a "**Weekly Entry Period**"), and one (1) grand prize drawing (the "**Grand Prize Drawing**") that will be conducted at the conclusion of the Sweepstakes Period, as detailed in the Entry Period Chart below.

All dates are subject to change, and any changes will be updated in these Official Rules and shared via the Website, as specified below. ALL non-winning Entries, as defined below, WILL roll over to subsequent Weekly Entry Periods, if any, and all Entries will be entered into the Grand Prize Drawing.

The sponsor of this Sweepstakes is Ollie's Bargain Outlet, Inc., 6295 Allentown Boulevard, Suite 1, Harrisburg, PA 17112 ("**Sponsor**"). The administrator of this Sweepstakes is Creative Zing Promotion Group, 2100 E. Robinson St., Orlando, FL 32803 ("**Administrator**"). The Sweepstakes is void where restricted or prohibited by law.

2. ELIGIBILITY: Sweepstakes is open only to legal United States residents physically residing within the fifty (50) United States or the District of Columbia who are physically located and residing therein and who are at least eighteen (18) years of age and the age of majority in their state of primary residence at the time of entry (the "**Entrant**"). Employees, shareholders, officers, directors, agents, and representatives of Sponsor and Administrator (collectively, "**Sweepstakes Entities**"), and each of their respective parent companies, affiliates, divisions, subsidiaries, agents, representatives and promotion and advertising agencies are not eligible to participate in the Sweepstakes. Photo must be 150 MB or less, and .jpg, .jpeg, .gif, .tif or .png format.

Weekly Entry Period Winners Prize will be sent to the Entrants address as provided on the Entry Form. Potential Grand Prize Winner will be required to respond (as directed) to the notification within seventy-two (72) hours of first attempted notification. Failure to respond within the stated time period may result in forfeiture of the Grand Prize. Cumulative ARV of all Prizes: \$5,000.

8. INDEMNITY: Each Entrant, Finalist and Grand Prize Winner shall indemnify, defend and hold harmless the Released Parties from and against any and all claims, damages, actions, liability, loss, injury or expense, including reasonable attorneys' fees and costs, arising out of or in connection with: (a) participation in the Sweepstakes;

(b) a breach or allegation which if true would constitute a breach of any of the representations, warranties or obligations herein; and (c) acceptance, possession, grant, or use of any prize, including without limitation, personal injury, death and property damage arising therefrom.

9. THE INVALIDITY OR UNENFORCEABILITY OF ANY PROVISION OF THESE RULES SHALL NOT AFFECT THE VALIDITY OR ENFORCEABILITY OF ANY OTHER PROVISION. IN THE EVENT THAT ANY PROVISION IS DETERMINED TO BE INVALID OR OTHERWISE UNENFORCEABLE OR ILLEGAL, THESE RULES SHALL OTHERWISE REMAIN IN EFFECT AND SHALL BE CONSTRUED IN ACCORDANCE WITH THEIR TERMS AS IF THE INVALID OR ILLEGAL PROVISION WERE NOT CONTAINED HEREIN.

10. DISPUTES: As a condition of participating in this Sweepstakes, Entrants agree that any and all disputes which cannot be resolved between the parties and causes of action arising out of or in connection with this Sweepstakes, shall be resolved individually, without resort to any form of class action or consolidated action, in accordance with the arbitration provision below. Further, in any such dispute, under no circumstances will Entrants be permitted to obtain awards for, and hereby waive all rights to claim punitive, incidental, or consequential damages, including without limitation attorneys' fees, other than Entrant's actual out-of-pocket expenses (e.g., costs associated with entering) if any, and Entrant further waives all rights to have damages multiplied or increased. Entrant agrees that any and all disputes, claims, and causes of action arising out of the Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class or other multi-party action, and exclusively by the appropriate court located in the City of Harrisburg in the Commonwealth of Pennsylvania.
